- R-6-16 Made by Dennis, seconded by Herlihy to authorize the Supervisor to execute the contract with the Onondaga County Sheriff's Department for Enhanced Services. All in favor. Motion carried.

- R-7-16 Made by Dennis, seconded by LaFace to execute the DOT Consortium Agreement for substance abuse testing with Industrial Medical Associates. All in favor. Motion carried.
- R-8-16 Made by Dennis, seconded by LaFace to approve the bank reconciliations of the Town Clerk and Supervisor. All in favor. Motion carried.
- R-9-16 Made by Dennis, seconded by LaFace to authorize the Supervisor to sign the Polling Place Location Lease with Onondaga County Board of Elections. All in favor. Motion carried.
- R-10-16 Made by Dennis, seconded by Lafrenz to send a letter in support of the Ironman 2016 to be held on Sunday, June 19, 2016. All in favor. Motion carried.
- R-11-16 Made by Herlihy, seconded by Marsh to execute a one year contract with Holbrook Heating for the maintenance of our HVAC systems. We will be charged on a per time hourly basis and the total charges will be below our procurement policy guidelines so that quotes for this service will not be needed. All in favor. Motion carried.

Steve Snell updated the Town Board on The Preserve drainage issues. A field visit was held on December 18th with Steve Snell, Tom Purcell, Greg Herlihy along with several members of the homeowner's association. He will be putting together a summary of what was found and recommendations on moving forward. Once the recommendations have been implemented and completed they should be maintained by the homeowner. There is a 1% slope so we should get a survey for a portion of it. This will need to be subcontracted out and Steve will try to get a cost of this too. The Preserve Drainage District will pay for this work. Currently there is \$3,500.00 in the budget and \$1,000.00 is allocated for other work. Tom Chartrand explained that we can loan money from the General Fund to this fund but it must be paid back in the next taxing cycle. This will affect our tax cap. Tom Purcell said that his department can help with the trucking. Steve Snell also stated that when a building permit is issued that silt fencing should be put up to prevent silt going into the drainage areas.

- R-13-16 Made by Dennis, seconded by LaFace to approve the payment of all bills. All in favor. Motion carried.

The monthly report of the Supervisor was submitted and reviewed. Court fees have exceeded budget. The mortgage tax came in at \$63,000.00 above budget. CHIPS money also was received.

The year-end Highway Report was submitted and reviewed.

Councilor Dennis stated that it is good that we have a good working relationship with the Town of Fabius. He also reported that Jonathan Mapstone will replace the outside electrical box on January 8, 2016.

Supervisor Marsh reported that she has been in contact with County Legislator David Knapp. Chris Ryan another County Legislator works for Verizon and informed him that they have locally approved DSL in Pompey Hill. This will be for people in the 677 exchange. They need to get money approved for fiber optics. She will keep us informed on this.

Public Comment

Jesse Walser commented that he has been informed that the backhalls are filled for the 677 exchange.

RESOLUTION APPOINTING JEFFREY D. BROWN, ESQ. TO THE OFFICE OF POMPEY TOWN ATTORNEY

The following resolution was offered by Supervisor Marsh, who moved its adoption, seconded by Councilor Dennis, to wit:

WHEREAS, the Town of Pompey desires to continue to maintain the office of Town Attorney in order enhance the efficiency and cost effectiveness of the delivery of legal services to the Town; and

WHEREAS, the general responsibilities of the Town Attorney are to negotiate, prepare, approve and audit written contracts, leases and other legal instruments; attend meetings of the Town Board, Planning Board and Zoning Board of Appeals; draft local laws and resolutions for consideration by the Town Board; create or extend special districts; provide legal advice and counsel to the Town Board, Planning Board and Zoning Board of Appeals; and provide litigation services to the Town on an asneeded basis; and

WHEREAS, the accomplishment of the above duties involves the exercise of discretion by the Town Attorney on behalf of the Town.

NOW, THEREFORE, BE IT RESOLVED, that Jeffrey D. Brown, Esq. is hereby re-appointed to the position of Town Attorney to perform the above-mentioned responsibilities for a term beginning January 1, 2016 and ending on December 31, 2017, at an annual compensation of \$35,500, plus any actual out of pocket expenses incurred in providing such services; and

BE IT FURTHER RESOLVED, that the Town Attorney position is considered a public office and as such the Town Attorney shall sign and file an oath of office with the Town Clerk.
