RESOLUTION APPOINTING JEFFREY D. BROWN, ESQ. TO THE OFFICE OF POMPEY TOWN ATTORNEY

The following resolution was offered by Supervisor Marsh, who moved its adoption, seconded by Councilor Herlihy, to wit:

WHEREAS, the Town of Pompey desires to continue to maintain the office of Town Attorney in order enhance the efficiency and cost effectiveness of the delivery of legal services to the Town; and

WHEREAS, the general responsibilities of the Town Attorney are to negotiate, prepare, approve and audit written contracts, leases and other legal instruments; attend meetings of the Town Board, Planning Board and Zoning Board of Appeals; draft local laws and resolutions for consideration by the Town Board; create or extend special districts; provide legal advice and counsel to the Town Board, Planning Board and Zoning Board of Appeals; and provide litigation services to the Town on an as-needed basis; and

WHEREAS, the accomplishment of the above duties involves the exercise of discretion by the Town Attorney on behalf of the Town.

NOW, THEREFORE, BE IT RESOLVED, that Jeffrey D. Brown, Esq. is hereby re-appointed to the position of Town Attorney to perform the above-mentioned responsibilities for a term beginning January 1, 2018 and ending on December 31, 2019, at a salary established by the Town Board, plus any actual out of pocket expenses incurred in providing such services; and

BE IT FURTHER RESOLVED, that the Town Attorney position is considered a public office and as such the Town Attorney shall sign and file an oath of office with the Town Clerk.
